- The institution shall make admission only after it obtains affiliation from the 111. examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.
- IV. The Institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- Further, the recognition/permission is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / Body, the State Government etc, as applicable.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at 5. the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- The institution shall maintain its website with hyperlink to the Council and the 6.
